## **MEDICAL CERTIFICATES**

Onshore enrollment: If you are enrolled in an onshore program your medical certificate must be issued by a registered Australian health practitioner.

Offshore enrolment: If you are enrolled in an offshore program or are studying offshore as part of your program requirements, you may submit an international medical certificate. This documentation must be completed in English or have a certified English translation.
