Duties

- Contribute to the development, delivery, and evaluation of curriculum in the nominated teaching area.
- Assess student performance through formative and summative tasks and provide timely, constructive feedback.
- Monitor and report on academic progress, liaising with student support staff as required.
- Apply reflective teaching practices to support students from diverse backgrounds, including EAL and low socio-economic cohorts.
- Demonstrate sound pedagogical approaches across face-to-face, blended, and online delivery modes for international and domestic students.
- Use ICT effectively for teaching and learning, including learning management systems, MS Office 365, authenticity tools, and screen-casting applications.
- Maintain professional credentials and expertise through classroom teaching and participation in relevant professional development activities.
- Undertake additional duties as directed by the Academic Manager.
