Through effective leadership, performance management, and collaboration, the position drives commercial growth, operational efficiency, and continuous improvement across UQ College's offerings.

The role requires domestic and international travel to support recruitment, partnership and program development and delivery.

## **Duties**

## **Leadership and strategic management**

- Lead and manage the business development team to achieve recruitment targets through effective promotional strategies and high-quality service delivery to institutional partners and agents.
- Lead strategic projects from inception to implementation, including drafting project briefs and reports.
- Collaborate with UQ Future Students to support pathway program pipelines, meet student load targets, and contribute to marketing, events, and agent engagement.
- Oversee the development and execution of annual international recruitment and marketing plans to drive commercial growth across targeted markets and programs.
- Engage with administrative and academic teams to enhance the operational performance and delivery of customised programs and study tours.
- Facilitate work-in-progress meetings to coordinate timelines, resources, and deliverables, and oversee program evaluations to improve group programs and study tours.
- Manage the creation and maintenance of business development tools, including proposal templates, presentations and other collateral.
- Oversee budget planning and expenditure for business development and program delivery activities, ensuring alignment with strategic priorities and financial targets.

#### **Customer service and cross-functional collaboration**

- Ensure the Business Development team provides accurate, timely, and high-quality service across all client touchpoints (email, phone, in-person, webinars, proposals, onboarding webinars).
- Foster collaboration with UQ Future Students, Global Partnerships, faculties, schools, central divisions and external partners to support shared goals.
- Maintain team knowledge of UQC and UQ programs, marketing campaigns, websites, databases, policies and governance frameworks.

### Market intelligence and operational improvement

- Monitor changes in student and business markets and deliver timely market analysis reports to Executive Management and relevant stakeholders.
- Evaluate current operational practices and performance metrics to implement initiatives that optimise efficiency and service quality.

## **Other Duties**

 Undertake additional responsibilities as directed by the Associate Director Business Development.

- Demonstrated success in building and managing relationships with internal and external stakeholders, including negotiating shared outcomes and navigating competing priorities across organisational boundaries and cultural backgrounds.
- Experience in managing student recruitment pipelines, including agent engagement and conversion strategies, with a focus on achieving enrolment targets and market growth.
- Proven ability to project manage the development of customised education programs and strategic projects, including planning, execution, evaluation, and reporting.
- Strong organisational and administrative skills, with the ability to manage multiple priorities, meet deadlines under pressure, and maintain high attention to detail.
- Excellent written and verbal communication skills, with the ability to collaborate effectively across teams, faculties, and external partners to support strategic initiatives.
